## Our Mission

Animal Victory's program is dedicated to providing relief for animals impacted by natural disasters or other crises, in addition to combatting overpopulation, and pushing for animal rights, through the implementation of various projects.

### Solving The Problem:

We have three projects that make up our program. Each project shares our mission and vision, albeit different roads taken, and are a culmination of today's issues that need to be addressed to protect animals from abuse.

1. **Saving Animals In Crises And Disasters**
2. **Begging For Help.**
3. **Home Street Home.**

We believe the overpopulation of dogs and cats is the number one reason dogs and cats are abused. There are too many of them, and not enough homes; thus leaving the unwanted to starve, freeze, or subjected to abuse by humans. The overpopulation also critically affects community resources, the environment, and socio-economic conditions. Our low-cost spay and neuter project for dogs and cats living on the streets is fundamental in addressing the core issue of their abuse.

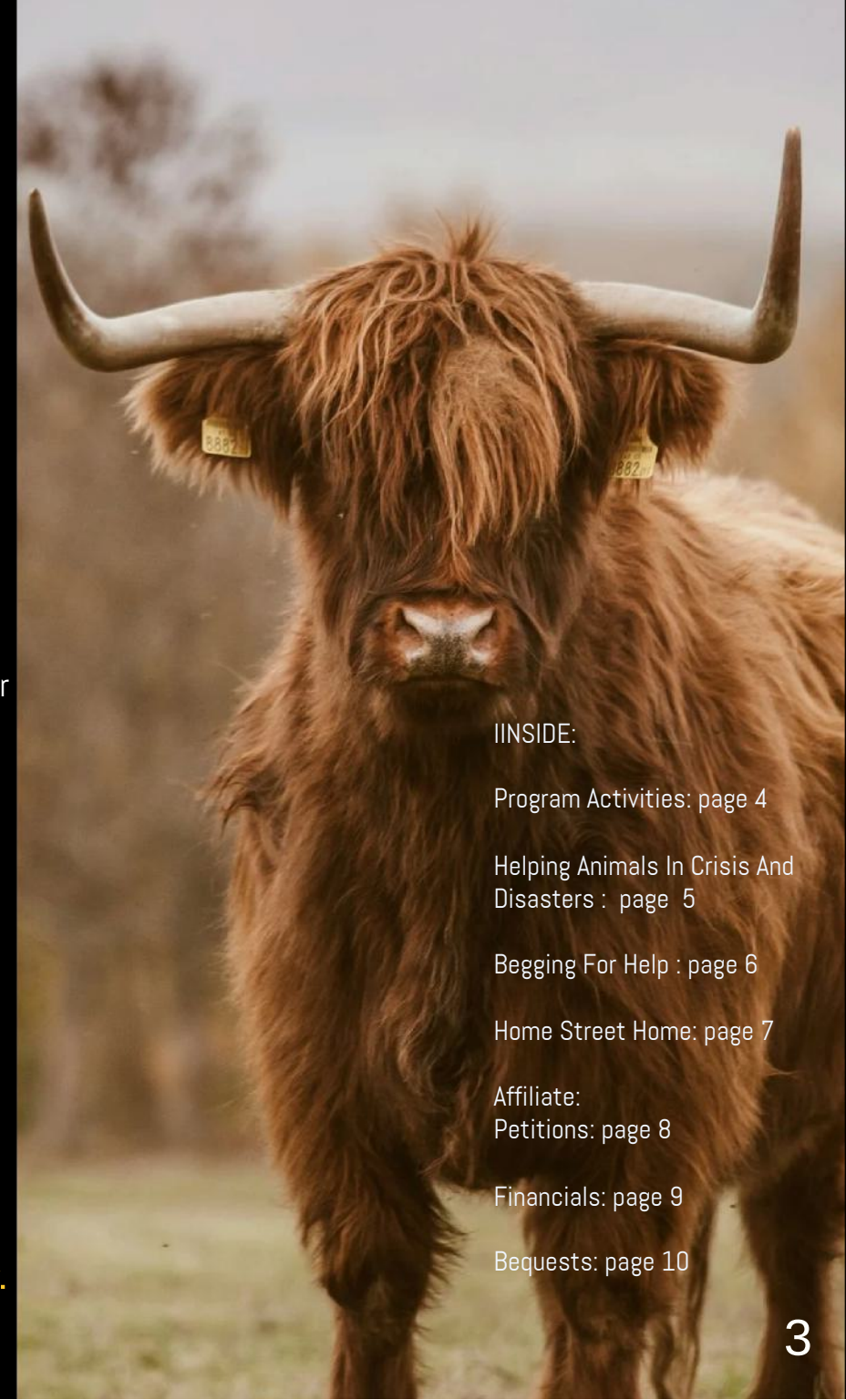
**We aim to reduce population growth rates.**

In addition, our petition platform advocates for animal rights and welfare. We support shelters and rescue organizations that work to provide care and shelter for abandoned and abused animals. We also support campaigns and legislation that aim to protect animals from cruelty and exploitation. Overwhelming research indicates there is a direct correlation between animal abuse and domestic abuse.

**We aim to reduce animal abuse and consequently domestic abuse.**

Our efforts in assisting the immediate concerns from natural disasters, war, and other crisis as they occur, are combatting overpopulation and working towards creating awareness to promote animal rights. These efforts are essential for creating a sustainable and humane world for future generations. By investing in these projects:

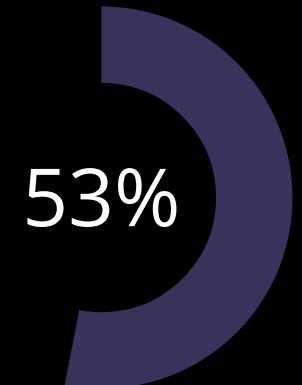




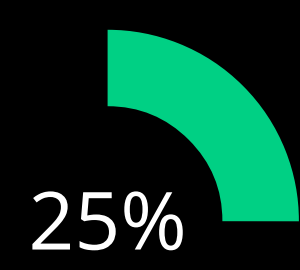
In 2024, our program services benefited approximately 3065 animals based upon \$30.00 per animal. 53% of our program expenses went towards Helping Animals In Crises And Disasters, 25% to our Begging For Help project, and 22% to our Home Street Home project. These allocations are based on the amount of donations received for each project.



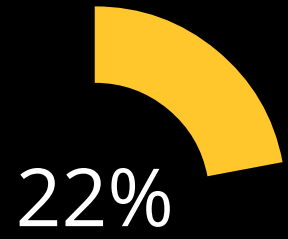
Helping Animals In Crises

## Helping Animals In Crises And Disasters Project



This project is a lifeline for animals caught in the chaos of natural disasters and war zones. Through the concerted efforts of our affiliates and connections in the affected regions, we deploy supplies and funds swiftly and efficiently.

### **2024 Results:**

**In 2024 we worked with 16 organizations/individuals.**

Since the inception of this project in 2022, we have worked with 36 organizations/individuals assisting close to 4000 animals.

- 13 Ukraine/Russia War
- 3 Colorado Marshall Fires
- 3 Israel/Hamas War
- 2 Hurricane Ian
- 2 Syria Earthquake
- 13 Hurricane Helene





## Begging For Help Project



Our distinctive funding initiative provides vital financial assistance for low-cost spay and neuter services for dedicated, sustainable, smaller groups and individuals within the United States who tap into their resources to control the population of cats and dogs in their local communities by spaying or neutering.

The ultimate objective is to maintain a balanced population of these animals. Our initiative contributes to the health and safety of communities and reduces animal cruelty by decreasing the number of stray animals on the streets.

### **2024 Results:**

In 2024, since the inception of this project we worked with 18 organizations/ individuals providing low cost spay and neuter services for approximately 400 dogs and cats.





## Home Street Home Project



Home Street Home serves dogs and cats belonging to individuals experiencing homelessness. This program is an organized annual effort, particularly active during the November and December holidays, aimed at providing food, supplies, and veterinary care for these pets.

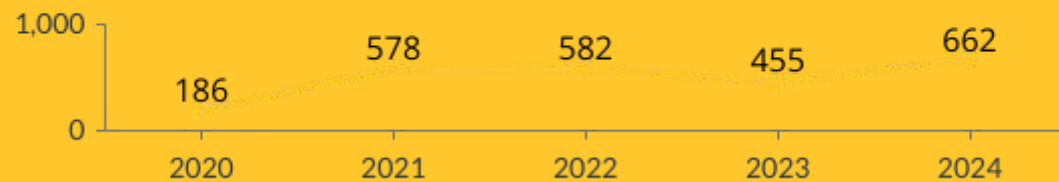
### 2024 Results:

Distributed 640 Holiday Love Bags in CA & WA with our affiliates -  
Taking it to the Streets and Adams County Pet Rescue.

AVDAF collaborates with its affiliate, Animal Victory, a for-profit organization, to shoulder operating costs. This compassionate advocacy group battles against animal abuse using petitions to persuade officials to investigate animal abusers and/or to sentence the maximum punishment for convicted animal abusers.

By jointly managing overhead, marketing, and administrative expenses, both organizations conserve resources. They leverage petitions and other campaigns to promote animal welfare issues, reaching a larger audience and gaining wider exposure to animal aid.

For those seeking a tax deduction while supporting our petition efforts, donations can be made through the AVDAF, creating a win-win situation.

In 2024, 68% of our program expenses were for the following projects. 36% of our program expenses went towards Helping Animals In Crises And Disasters, 17% to our Begging For Help project, and 15% to our Home Street Home project. These allocations are based on the amount of donations received for each project. Operational and fundraising costs make up 32% of our budget.

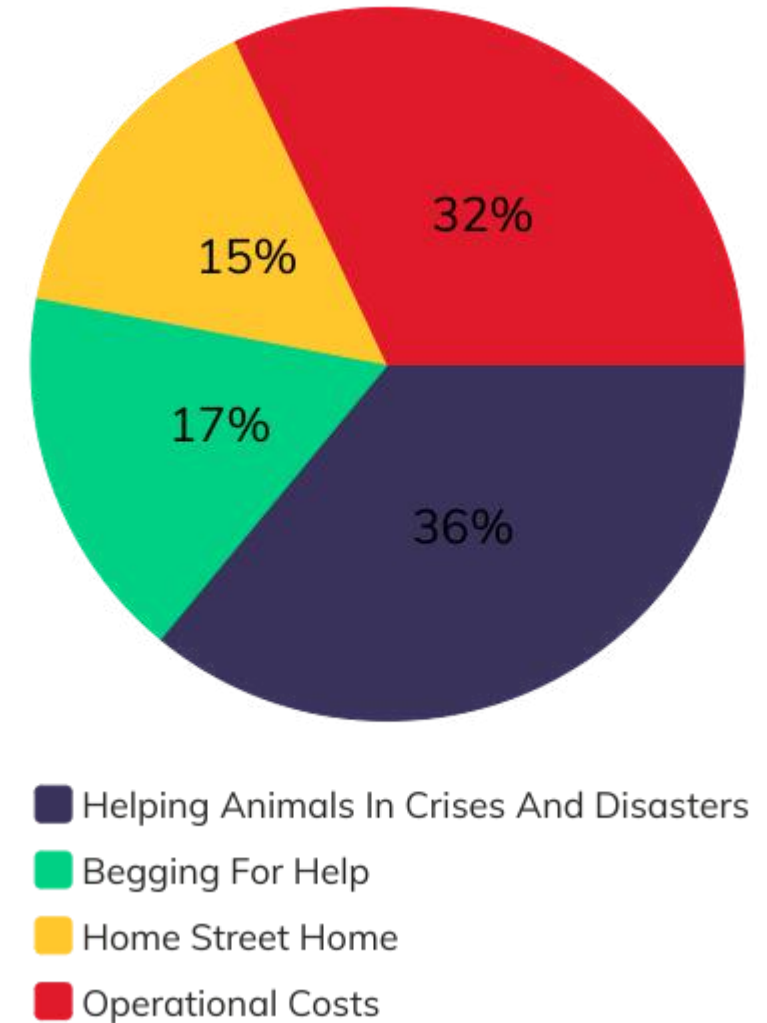
Based on the breakdown of program expenses in 2024, it is clear that the majority of our funds are being directed towards Helping Animals In Crises And Disasters. This is directly proportional to the amount of donations received for the project and reflective of our commitment to providing support and resources to animals in need during times of crisis and disasters.

The Begging For Help project also received a significant portion of our program expenses, directly proportional to the amount of donations received for the project, indicating that it is a priority for animal lovers and our organization to address issues related to overpopulation.

Lastly, the Home Street Home project received 15% of our program expenses, highlighting our dedication to helping pets of individuals experiencing homelessness find stable and secure housing solutions.

It is important to note that operational costs make up 32% of our budget, which includes shared overhead costs for our Petition Publishing and fundraising. This indicates that a portion of our funds is allocated towards ensuring the smooth operation and administration of our programs and initiatives.

Overall, the breakdown of program expenses in 2024 reflects our organization's commitment to supporting animals in crises, and addressing overpopulation ensuring the effective operation of our programs.

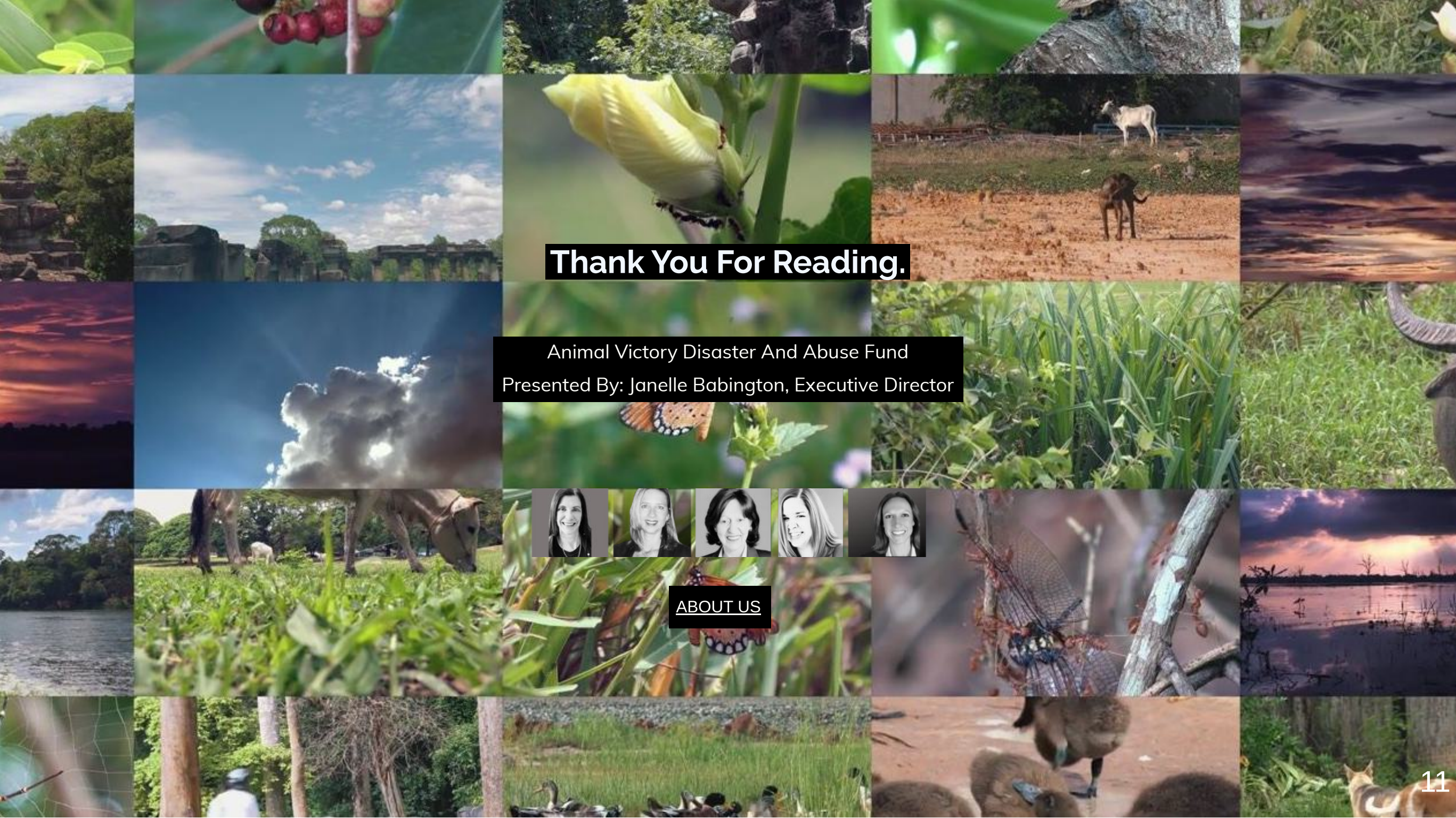
