GENERAL TERMS

Cancellation: Either party may terminate this agreement at any time by providing 24-hour written notice via email. No further billing will occur after the cancellation notice is received. If a Sponsor cancels after payment has been made for the current month, a pro-rated refund will be issued based on the number of remaining unused weeks in that billing month. No refunds will be issued for services already rendered. Example: if a Sponsor cancels after two weeks of a four-week month, a 50% refund of that month's fee will be returned within 5 business days.

Use of Name & Logo: Sponsor grants AVDAF / The Animal Court Podcast permission to use the Sponsor's name and logo solely for the purposes described in this agreement. AVDAF / The Animal Court Podcast grants the Sponsor permission to reference the partnership in their own marketing materials.

No Guarantee of Results: AVDAF / The Animal Court Podcast does not guarantee specific audience numbers, download figures, open rates, or donation outcomes. Reach figures stated are current estimates and may vary.

Governing Law: This agreement shall be governed by and construed in accordance with the laws of the State of North Carolina, including the North Carolina Nonprofit Corporation Act, Chapter 55A of the North Carolina General Statutes (https://www.ncleg.net/enactedlegislation/statutes/html/bychapter/chapter_55a.html), which governs the creation, operation, and contractual authority of nonprofit corporations in North Carolina. AVDAF operates as a federally recognized 501(c)(3) nonprofit organization under the Internal Revenue Code. All sponsorship funds are used exclusively in furtherance of the organization's exempt purpose. Any disputes arising under this agreement shall be resolved in the courts of New Hanover County, North Carolina.

LIABILITY WAIVER

The Sponsor agrees to release, indemnify, and hold harmless AVDAF / The Animal Court Podcast, its officers, directors, employees, volunteers, and agents from and against any and all claims, damages, losses, costs, or

expenses (including reasonable attorney's fees) arising out of or related to the Sponsor's participation in this sponsorship agreement.
